THIS TWELFTH SUPPLEMENTAL INDENTURE, made and entered into as of the first day of January, 2008, by and between THE REGENTS OF THE UNIVERSITY OF CALIFORNIA, a corporation organized and existing under and by virtue of Article IX, Section 9, of the Constitution of the State of California (herein called "The Regents"), and THE BANK OF NEW YORK TRUST COMPANY, N.A. (as successor in interest to BNY Western Trust Company), a national banking association duly organized and existing under and by virtue of the laws of the United States of America, having a principal office in San Francisco, California, and being qualified to accept and administer the trusts hereby created (herein called the "Trustee"),

WITNESSETH:

WHEREAS, The Regents has heretofore authorized the issuance of its General Revenue Bonds issued under an indenture, dated as of September 1, 2003, as heretofore supplemented (the "2003 Indenture") by and between The Regents and the Trustee, in such series as from time to time shall be established and authorized by The Regents;

WHEREAS, the 2003 Indenture provides that The Regents may from time to time establish series of Bonds by supplemental indenture, and that The Regents may issue and the Trustee may authenticate and deliver Bonds of any such series in such principal amount as shall be determined by The Regents, upon compliance with the provisions, and subject to the conditions, set forth in the 2003 Indenture;

WHEREAS, The Regents has now determined to use the proceeds of the sale of the 2008 Series L Bonds (hereinafter defined) to finance or refinance the acquisition and construction of certain facilities of the University of California, including, but not limited to student centers, recreation and events facilities, research facilities, housing facilities, certain seismic retrofitting improvements and certain academic, administrative and other facilities of the University;

WHEREAS, in order to obtain funds for such purpose, The Regents desires to issue, sell and deliver \$208,025,000 aggregate principal amount of The Regents of the University of California General Revenue Bonds, 2008 Series L (the "2008 Series L Bonds"), all under and in accordance with the 2003 Indenture and this Twelfth Supplemental Indenture (collectively, the "Indenture");

WHEREAS, the 2008 Series L Bonds and the Trustee's certificate of authentication to appear thereon, and assignment to appear thereon, shall be in substantially the form, with necessary or appropriate variations, omissions and insertions, as permitted or required by the Indenture, as set forth in Exhibit A, attached hereto;

WHEREAS, The Regents certifies that all acts and proceedings required by law necessary to make the 2008 Series L Bonds when executed by The Regents, authenticated and delivered by the Trustee and duly issued, the valid, legal and binding limited obligations of The Regents, payable out of General Revenues as provided in the Indenture, and to constitute this Twelfth Supplemental Indenture a valid and binding agreement for the uses and purposes herein set forth, in accordance with its terms, have been done and taken; and the execution and delivery of this Twelfth Supplemental Indenture have been in all respects duly authorized;

NOW THEREFORE, THIS TWELFTH SUPPLEMENTAL INDENTURE WITNESSETH, that in order to secure the payment of the principal of, premium, if any, and interest on, all Bonds at any time issued and Outstanding pursuant to the Indenture as from time to time supplemented and amended, and to secure the performance and observance of the covenants and conditions therein and herein set forth, and to declare the terms and conditions upon and subject to which the 2008 Series L Bonds are to be issued and received, and for and in consideration of the premises and of the mutual covenants herein contained and of the purchase and acceptance of the 2008 Series L Bonds by the owners thereof, and for other valuable consideration, the receipt of which is hereby acknowledged, The Regents covenants and agrees with the Trustee, for the equal and proportionate benefit of the respective owners from time to time of the Bonds, as follows:

## ARTICLE XXIII

### 2008 SERIES L BONDS

**SECTION 23.01** Definitions. Unless the context otherwise requires, the terms defined in this Section 23.01 shall, for all purposes of the 2003 Indenture and this Twelfth Supplemental Indenture, have the meanings herein specified. All other terms defined in the 2003 Indenture and used herein shall have the meanings assigned to such terms in the 2003 Indenture.

#### **Authorized Denomination**

“Authorized Denomination” means \$5,000 or any integral multiple thereof with respect to 2008 Series L Bonds.

#### **Beneficial Holder**

“Beneficial Holder” means any Person who has the power, directly or indirectly, to vote or consent with respect to, or to dispose of ownership of, any 2008 Series L Bond, including, without limitation, any Persons holding bonds through nominees or depositories.

#### **Interest Payment Date**

“Interest Payment Date” shall have the meaning as given in Section 23.03 of this Twelfth Supplemental Indenture.

#### **Participating Underwriter**

“Participating Underwriter” means any of the original underwriters of the 2008 Series L Bonds required to comply with Rule 15c2-12(b)(5) adopted by the Securities and Exchange Commission under the Securities Exchange Act of 1934, as the same may be amended from time to time, in connection with the offering of the 2008 Series L Bonds.

#### **Record Date**

“Record Date” shall have the meaning as given in Section 23.03 of this Twelfth Supplemental Indenture.

## **2008 Series L Bonds**

“2008 Series L Bonds” means The Regents of the University of California General Revenue Bonds, 2008 Series L, authorized under and secured by the 2003 Indenture and this Twelfth Supplemental Indenture.

## **2008 Series L Projects**

“2008 Series L Projects” means the real property and improvements thereon financed or refinanced with the 2008 Series L Bonds, a preliminary list of which is attached hereto as Exhibit B.

## **Twelfth Supplemental Indenture**

“Twelfth Supplemental Indenture” means this Twelfth Supplemental Indenture, as executed by The Regents and the Trustee in accordance with the Indenture, and which is supplemental to the Indenture.

### **SECTION 23.02 Authorization of 2008 Series L Bonds.**

(A) A twelfth series of Bonds to be issued under the Indenture is hereby created and authorized to be issued, and such Bonds are designated as “The Regents of the University of California General Revenue Bonds, 2008 Series L.” The aggregate principal amount of 2008 Series L Bonds which may be issued and outstanding under the Indenture shall not exceed Two Hundred Eight Million Twenty-Five Thousand Dollars (\$208,025,000), exclusive of Bonds executed and authenticated as provided in Section 2.08 of the Indenture.

(B) The 2008 Series L Bonds are authorized and issued to finance the 2008 Series L Projects and to pay for Costs of Issuance of the 2008 Series L Bonds.

(C) The 2008 Series L Bonds shall be equally and ratably secured with all Bonds authorized in the Indenture to be issued or to be subsequently Outstanding thereunder, without preference, priority or distinction (other than with respect to terms of maturity, interest payment dates, sinking fund payments or provisions for redemption) of any one Bond over any other or of the Bonds of any one Series over any other Series, except as otherwise provided in the Indenture.

### **SECTION 23.03 Terms of 2008 Series L Bonds.**

(A) The 2008 Series L Bonds shall bear interest at the rates per annum, payable semiannually on May 15 and November 15 in each year (each, an “Interest Payment Date”), commencing November 15, 2008, until payment of the principal of said Bonds and shall mature on May 15 in each of the years, and in the amounts, as follows:

The principal of the 2008 Series L Bonds shall be payable at the corporate trust office of the Trustee in San Francisco, California, in lawful money of the United States of America. The interest thereon is payable to the person whose name appears on the bond registration books of the Trustee as the registered owner thereof as of the close of business on the first day of the month in which the Interest Payment Date occurs (the "Record Date"), whether or not such day is a Business Day, such interest to be paid by check or draft mailed to such registered owner at his or her address as it appears on such registration books.

(B) The 2008 Series L Bonds shall be issued as fully registered Bonds without coupons in Authorized Denominations and shall be numbered consecutively from 1 upwards with the prefix R- preceding each number. The 2008 Series L Bonds shall be substantially in the form set forth in Exhibit A.

(C) The 2008 Series L Bonds shall be dated as of the date of original delivery, and shall be registered on the date of registration noted on such Bond by the Trustee. Each 2008 Series L Bond shall bear interest from the Interest Payment Date next preceding the date of registration thereof unless such date of registration is an Interest Payment Date, in which event it shall bear interest from the date of registration thereof, or unless it is registered on or before November 15, 2008, in which event it shall bear interest from the date of original delivery. The

2008 Series L Bonds may be exchanged and transferred as provided in Article II of the Indenture, provided that no exchange or transfer need be made by the Trustee during the period beginning on the first day of the month in which the Interest Payment Date occurs and ending on such Interest Payment Date.

**SECTION 23.04      Redemption of 2008 Series L Bonds.**

(A) The 2008 Series L Bonds maturing on or before May 15, 2016 are not subject to optional redemption. The 2008 Series L Bonds maturing on or after May 15, 2017 are subject to redemption prior to their respective stated maturities, at the option of The Regents from lawfully available funds deposited in the 2008 Series L Optional Redemption Subaccount of the Optional Redemption Account, established by The Regents pursuant to subparagraph (D) of Section 23.06 herein, as a whole or in part (in such order of maturity as shall be selected by the Trustee upon direction by The Regents and by lot within a maturity) on any date, on or after May 15, 2016 at the following redemption prices (expressed as percentages of the principal amount of 2008 Series L Bonds called for redemption) together with interest accrued thereon to the date fixed for redemption:

(B) The 2008 Series L Bonds maturing on May 15, 2033, are subject to redemption prior to maturity in part, by lot, at the principal amount thereof plus accrued interest to the date fixed for redemption, without premium, from Mandatory Sinking Account Payments in the following amounts, commencing on May 15, 2029 according to the following schedule:

(C) The 2008 Series L Bonds maturing on May 15, 2036, are subject to redemption prior to maturity in part, by lot, at the principal amount thereof plus accrued interest to the date fixed for redemption, without premium, from Mandatory Sinking Account Payments in the following amounts, commencing on May 15, 2034 according to the following schedule:

(D) The 2008 Series L Bonds maturing on May 15, 2038, are subject to redemption prior to maturity in part, by lot, at the principal amount thereof plus accrued interest to the date fixed for redemption, without premium, from Mandatory Sinking Account Payments in the following amounts, commencing on May 15, 2037 according to the following schedule:

(E) The 2008 Series L Bonds maturing on May 15, 2040, are subject to redemption prior to maturity in part, by lot, at the principal amount thereof plus accrued interest to the date fixed for redemption, without premium, from Mandatory Sinking Account Payments in the following amounts, commencing on May 15, 2039 according to the following schedule:

(F) Whenever provision is made for the redemption of a portion of the 2008 Series L Bonds of a maturity date, the Trustee shall select the 2008 Series L Bonds to be redeemed by lot.

(G) Except as in this Section otherwise provided, the redemption of 2008 Series L Bonds shall be subject to the provisions of Article IV of the Indenture.

**SECTION 23.05 Issuance of 2008 Series L Bonds.** The Trustee, forthwith upon the execution and delivery of this Twelfth Supplemental Indenture and of the other documents required by Section 3.01 of the Indenture, or from time to time thereafter, upon the execution and delivery to it by The Regents of the 2008 Series L Bonds, and without any further action on the part of The Regents, shall authenticate 2008 Series L Bonds in the aggregate principal amount of Two Hundred Eight Million Twenty-Five Thousand Dollars (\$208,025,000) and shall deliver them to or upon the Written Order of The Regents.



**SECTION 23.06      Application of Proceeds; Establishment of 2008 Series L**

**Funds.**

(A) The proceeds received by the Trustee upon the sale of the 2008 Series L Bonds (following the payment of the underwriters' discount (\$1,021,416.71)) shall be applied or deposited as follows:

(1) \$251,200.69 shall be transferred to The Regents for deposit in the 2008 Series L Costs of Issuance Fund established by The Regents pursuant to subparagraph (B) of this Section; and

(2) \$218,458,207.00 shall be transferred to The Regents for deposit in the 2008 Series L Construction Account established pursuant to subparagraph (C) of this Section.

(B) 2008 Series L Costs of Issuance Fund. The Regents shall establish and maintain a fund designated as the "2008 Series L Costs of Issuance Fund." Moneys in the 2008 Series L Costs of Issuance Fund shall be used to pay Costs of Issuance with respect to the 2008 Series L Bonds, and at the end of six months from the date of issuance of the 2008 Series L Bonds, or upon earlier determination by The Regents that the amounts in said fund are no longer required for payment of Costs of Issuance, said fund shall be terminated and any amounts then remaining in said fund shall be transferred to the Trustee for deposit in the Debt Service Fund.

(C) 2008 Series L Construction Account. The Regents shall establish and maintain a separate account designated as the "2008 Series L Construction Account." Moneys in the 2008 Series L Construction Account shall be used and withdrawn by The Regents to pay the cost of the acquisition, construction, improvement and/or renovation of the 2008 Series L Projects, including reimbursements of any sums advanced by The Regents for such purposes and refunding borrowings of The Regents incurred for such purposes, and to pay interest on the 2008 Series L Bonds in such amounts and on such dates as determined by The Regents. Amounts in the 2008 Series L Construction Account may be invested in Investment Securities. Upon completion of the 2008 Series L Projects, any amounts remaining in the 2008 Series L Construction Account shall be applied to pay the interest on the 2008 Series L Bonds or to pay other capital expenditures of The Regents.

(D) 2008 Series L Optional Redemption Subaccount. The Trustee shall establish and maintain a subaccount designated as the "2008 Series L Optional Redemption Subaccount." Moneys in the 2008 Series L Optional Redemption Subaccount shall be used for the redemption or purchase of 2008 Series L Bonds from money allocable to the 2008 Series L Bonds and required, pursuant to Section 23.04(A) of this Twelfth Supplemental Indenture, to be deposited into such subaccount.

**SECTION 23.07      Tax Covenants.** The Regents will not make any use of the proceeds of the 2008 Series L Bonds or any other funds of The Regents which will cause any 2008 Series L Bond to be an "arbitrage bond" subject to federal income taxation by reason of Section 148 of the Code, or a "federally-guaranteed obligation" under Section 149(b) of the Code, or a "private activity bond" as described in Section 141 of the Code. To that end, The Regents, with respect to such proceeds and such other funds will comply with all requirements of

such sections of the Code and all regulations of the United States Department of the Treasury issued thereunder to the extent that such requirements are, at the time, applicable and in effect.

If at any time The Regents is of the opinion that for purposes of this Section it is necessary to restrict or limit the yield on or change in any way the investment of any moneys held by the Trustee or under the Indenture, The Regents shall so instruct the Trustee or the appropriate officers of The Regents in writing, and the Trustee or the appropriate officers of The Regents, as the case may be, shall take such actions as may be necessary in accordance with such instructions.

In furtherance of the covenants of The Regents set forth above, The Regents will comply with the Tax Certificate and will cause the Trustee to comply with the Tax Certificate.

**SECTION 23.08**     **Terms of 2008 Series L Bonds Subject to the Indenture.**


Except as in this Twelfth Supplemental Indenture expressly provided, every term and condition contained in the Indenture shall apply to this Twelfth Supplemental Indenture and to the 2008 Series L Bonds with the same force and effect as if the same were herein set forth at length, with such omissions, variations and modifications thereof as may be appropriate to make the same conform to this Twelfth Supplemental Indenture. As supplemented by this Twelfth Supplemental Indenture, the 2003 Indenture is hereby confirmed.


**SECTION 23.09**     **Article and Section Headings.** The headings or titles of the several Articles and Sections hereof, and any table of contents appended to copies hereof, shall be solely for convenience of reference and shall not affect the meaning, construction or effect of this Twelfth Supplemental Indenture.

**SECTION 23.10**     **Execution in Several Counterparts.** This Twelfth Supplemental Indenture may be executed in any number of counterparts and each of such counterparts shall for all purposes be deemed to be an original; and all such counterparts, or as many of them as The Regents and the Trustee shall preserve undestroyed, shall together constitute but one and the same instrument.

IN WITNESS WHEREOF, THE REGENTS OF THE UNIVERSITY OF CALIFORNIA has caused this Twelfth Supplemental Indenture to be signed in its corporate name by its Chairman and its Secretary and Chief of Staff, and THE BANK OF NEW YORK TRUST COMPANY, N.A., in token of its acceptance of the trusts created hereunder, has caused this Twelfth Supplemental Indenture to be signed in its corporate name by one of its Vice Presidents, all as of this day and year first above written.



The Regents of the University of California, a corporation organized and existing under Article IX, Section 9, of the Constitution of the State of California (herein called "The Regents"), for value received, hereby promises to pay (but only out of General Revenues as hereinafter provided) to the registered owner referred to above or registered assigns on the maturity date referred to above (subject to any right of prior redemption hereinafter expressly reserved) the principal sum specified above, together with interest on such principal sum from the interest payment date next preceding the date of registration of this Bond (unless such date of registration is an interest payment date, in which event it shall bear interest from such date of registration, or unless this Bond is registered on or before November 15, 2008, in which event it shall bear interest from the original issue date specified above) until the principal hereof shall have been paid at the interest rate per annum specified above (based on a 360-day year consisting of twelve 30-day months), payable on November 15, 2008, and semiannually thereafter on each May 15 and November 15.

The principal or redemption price hereof is payable upon presentation and surrender hereof at the corporate trust office of The Bank of New York Trust Company, N.A. (as successor in interest to BNY Western Trust Company) (herein called the "Trustee"), in San Francisco, California, and interest shall be paid by check mailed to the person in whose name this Bond is registered as of the close of business on the first day of the month in which an interest payment date occurs, at the address of such registered owner shown on the books of the Trustee.

This Bond is one of a duly authorized issue of Bonds of The Regents designated as "The Regents of the University of California General Revenue Bonds" (herein called the

“Bonds”), unlimited in aggregate principal amount, except as otherwise provided in the Indenture hereinafter mentioned, of the series and designation indicated on the face hereof, which issue of Bonds consists or may consist of one or more series, of varying dates, numbers, interest rates and other provisions as in said Indenture provided, all issued under an indenture, dated as of September 1, 2003, by and between The Regents and the Trustee, as heretofore supplemented and as supplemented by a Twelfth Supplemental Indenture, dated as of January 1, 2008, by and between The Regents and the Trustee (as so supplemented, the “Indenture”). This Bond, together with all other Bonds issued under the Indenture, is authorized to be issued pursuant to the powers and authority of The Regents contained in Article IX, Section 9 of the Constitution of the State of California. The Bonds are limited obligations of The Regents to which The Regents is obligated to apply only the General Revenues (herein called the “General Revenues”) as defined in, and only to the extent required by, the Indenture, to the payment of the principal of and interest and premium, if any, on the Bonds. This Bond is not a lien, charge or liability against the State of California or against The Regents or against the property or funds of either, except to the extent of the pledge of the General Revenues, as provided by the Indenture. Under the Indenture, the pledge and lien on General Revenues is junior to the pledge and lien of certain other indebtedness of The Regents, and the Indenture permits The Regents to incur additional indebtedness or obligations payable from General Revenues, including additional indebtedness or obligations secured by a pledge and lien on General Revenues senior in priority, on a parity with, or subordinate to, the pledge and lien of the Indenture. Reference is hereby made to the Indenture and all indentures supplemental thereto for a description of the rights thereunder of the owners of the Bonds, of the nature and extent of the security, of the rights, duties and immunities of the Trustee and of the rights and obligations of The Regents thereunder, to all of the provisions of which Indenture the owner of this Bond, by acceptance hereof, assents and agrees.

The Indenture and the rights and obligations of The Regents and the Trustee and the owners of the Bonds may be modified or amended from time to time and at any time in the manner, to the extent, and upon the terms provided in the Indenture; provided, however, that no such modification or amendment shall (1) extend the stated maturity of this Bond or reduce the rate of interest hereon, or extend the time of payment of interest, or reduce the amount of the principal hereof, or reduce any premium payable on the redemption hereof, without the consent of the owner hereof, or (2) reduce the percentage of owners of Bonds Outstanding whose consent is required for the execution of a supplemental indenture, without the consent of the owners of all Bonds then Outstanding.

The 2008 Series L Bonds are subject to redemption prior to maturity upon the conditions, at the times and at the redemption prices as set forth in the Indenture.

If an Event of Default, as defined in the Indenture, shall occur, the principal of all Bonds may be declared due and payable upon the conditions, in the manner and with the effect provided in the Indenture. The Indenture provides that in certain events such declaration and its consequences may be rescinded by the owners of at least a majority in aggregate principal amount of the Bonds then outstanding.

The 2008 Series L Bonds are issuable only as fully registered Bonds without coupons in denominations of \$5,000 or any integral multiple thereof. Subject to the limitations

and upon payment of the charges, if any, provided in the Indenture, 2008 Series L Bonds may be exchanged at the corporate trust office of the Trustee in San Francisco, California, for a like aggregate principal amount of Bonds of other authorized denominations. This Bond is transferable by the registered owner hereof, in person, or by its duly authorized attorney, but only in the manner, subject to the limitations and upon payment of the charges provided in the Indenture, and upon surrender and cancellation of this Bond. Upon such transfer, a new Bond or Bonds, of the same series, authorized denomination or denominations and for the same aggregate principal amount, will be delivered to the transferee in exchange herefor.
